RP&P.18/27 Election of Chairman of the Recreation, Parks & Property Committee for 2018/19:

Cllr Allen nominated Cllr Kelly as Chairman of the Recreation, Park and Property Committee for 2018/19 and Cllr Kelly accepted nomination. The nomination was seconded by Cllr Elphick

**Public Participation:

Ms N Wilson spoke supporting item RP&P.18/37 - Plastic Free Community Project. She advised that the project is already supported by local businesses and community groups and will be publicised by a film screening in the Distillery to raise awareness. It is hoped to attain the status/approval of the Surfers Against Sewerage Award.
