A report on the content, outcome of the event and recommendation in relation to the merits of preparing a Neighbourhood Plan for Bovey Tracey had previously been circulated. Taking into consideration the information gained and the recommendation in the report regarding Neighbourhood Plans, Members considered the following:

- i) In view of what the Town Council has already embodied in our Community Masterplan and the draft Local Plan, it is not felt appropriate to propose that Bovey Tracey should apply to TDC to prepare a Neighbourhood Plan at the present time.
- ii) Prioritising ten actionable projects, contained in the Community Master Plan, within an achievable timescale.

Resolved:

- i) To not proceed with the preparation of a Neighbourhood Plan at present but to review the matter in twelve months.
- ii) To request the S106 Committee (ref. min. no FR&GP.12/60) to progress with identifying ten projects contained in the Community Master Plan which can be achieved within the next twelve months.

PL.13/07. Proposed Cycle Parking Installation in Bovey Tracey:

It was noted that Devon County Council (DCC) has commissioned Jacobs to review and install cycle parking facilities across Devon. Two sites (*sites plans previously circulated) have been proposed to go forward for installation in Bovey Tracey.

Site 1: It is proposed to replace the existing stands at the Library. Site 2: Two new stands to be installed near to The Dolphin Hotel. Members have been requested to inform DCC if the Town Council has any comments or objections to progressing with the installation.

It was further noted that DCC is considering placing stands near the shops in Battle Road, Heathfield.

Further information available at the meeting advised that the offer of new stands at Site 2 had been withdrawn by DCC.
