PL.20/35 Minutes:

- i) The minutes of the meeting of 9th March 2020 (*copy previously circulated) were confirmed as a correct record and were approved.
- ii) Members noted and approved the observations made on application 20/00399/MAJ (BCT Factory, Old Newton Road, Heathfield) (*copy previously circulated). It was further agreed to include a request that the operating hours remain as originally set out or if a variation is required this should have wider consultation. It was noted that Cllr Kerswell will present the observations at the TDC Planning meeting.

- b) Enquired about the travellers that have gained entry into the DCC yard at Drumbridges. Cllr Gribble is progressing this with DCC and the Police.

Clir Brooke requested an update on the road situation from Thorn Cross to New Park. Clir Gribble confirmed that the matter is under discussion, parts of which are confidential at present.

Clir Kelly reported potholes in Lower Canon Road and Musket Road, Heathfield.
